- 1. President Jennifer Luechauer
 - O Val is working on booking all of our rooms for FMEA
 - She is worried that we might not be able to get as many as we want, but Jenn's room is covered by the FMEA board
 - Worst case, we cut one of the membership scholarship rooms
 - O Dr. Chipman might not be at Fall Con, Dr. Sanz will speak in his place
 - o Dr. Kelly might not be at Fall Con, so Dr. Sanz will give closing remarks in his place
 - We need to set a date for the last day of pre-registration
 - Potentially october 17, 18, or 19?
 - That gives us a little over a week to order the stuff that we need based off of preregistration numbers
 - October 19 will be the deadline for pre-registration
 - They can continue to register online up until the conference, but it goes up to \$10 starting October 20th
 - We will place orders for folders and supplies on October 20th
 - We need to ask presenters for any handouts they would like us to print either late this week or early next week
 - Once we get the number of how much stuff we need to order/print, we can get it ordered

2. President-Elect - Katherine Attong-Mendes

- We have the application for Fall Con hotel scholarships ready to go
 - o It's a document that chapter members will fill out and submit to us via email
 - We budgeted for two rooms for both nights (October 27-28)
 - Requires personal information, personal statement, and proof of CNAfME membership
- We need to ask Val when is the last day to cancel a room reservation, because that will inform when the deadline is to apply for the scholarship

4. Secretary - Emma Harmon

- We have 19 people registered for Fall Con!!
- Information is on the facebook page, and there is a facebook event
 - We also sent all the info to FMEA, who published it on their website and facebook page
 - We also emailed every CNAfME member in the state of Florida that we had contact emails for with all of the info
 - Hotel info is now on facebook and has been emailed to all chapter advisors, presidents, and president-elects
- We can ask the FMEA web person to email everyone registered as a collegiate FMEA member

3. Treasurer - Tyler Marais

- We were looking at around \$6000 for Fall Con, but now we're at around \$4000
 - We over budgeted for the hotel rooms, so we saved around \$100 on hotels
 - We also over budgeted for the clinician fees

 - o They're all very excited and prepared
 - O We will keep working on them and editing them

 - Their presentation is going to be awesome
